COVERAGE

- Broad professional liability coverage available on a case-by-case basis, including coverage for property damage, bodily injury, consequential loss, and pollution arising from the provision of professional services

LIMITS, STRUCTURE & RISK SIZE

- Up to USD \$15M 100% Mosaic Syndicate Services Limited (MSSL)
- Limits preferably deployed in primary lead position, but will consider excess placements
- Practice policies preferred, but can consider single contracts on an annual basis when covering one insured for specific works
- Mosaic considers risks of all sizes, from single contractors to billion-dollar organizations
- No absolute thresholds, but premiums typically start for small risks at USD \$5K for a USD \$1M aggregate limit, and USD \$25K for a USD \$5M aggregate limit
